Westlake Village Art Guild 2018 Member's Show

Gallery Hours: Monday through Saturday, 11:00 AM to 5:00 PM and by appointment.

- Open to WVAG Members only.
- Maximum of 2 works per artist not to exceed a TOTAL of 25 square feet (with frame).
- Maximum 60" x 60" and weight not to exceed 60 pounds (combined).
- Only gallery wired work (no saw tooth hangers).
- Professionally Finished; appropriate framing or *standard* Gallery Wrapped.
- All work must be original and created by the submitting artist and not done under supervision.
- Source materials, including photographs, must be the artists' own.
- No work previously hung at a WVAG show.
- All exhibiting artists are required to sit/staff the Gallery or pay a \$30 fee if they are unable to do so. Exhibiting artists over the age of 78 years are exempt from this requirement.
- All work subject to a 30% fee for commission.
- **No Reproductions Accepted.**

I, _____, certify that each artwork listed on the reverse side is my original work and not a reproduction, copy, class work, or other work identified as ineligible elsewhere in the prospectus. I also certify that it has not been exhibited in previous WVAG shows. **I understand that, in the event of a misrepresentation, the work submitted may be deemed ineligible and any prizes or awards I received will be revoked.**

I also understand that, as a condition of entry, if I am younger than 78 years, I must sit the gallery a minimum of one (1) 3-hour shift or pay a \$30 fee in lieu of same. I understand that for each original work, print, or reproduction sold as a result of this exhibit, 20% of the proceeds will go to the City of Thousand Oaks and an additional 10% will go to the Westlake Village Art Guild.

I also understand and agree that I am entering my work and participating in this event voluntarily and at my own risk. I understand that I must provide insurance if I desire to protect my work against damage, theft, or loss of the work I enter. I hereby release the WVAG, its members, board and exhibit committee or agents and the City of Thousand Oaks or its agents from claims, liabilities, damages, theft or loss that may arise from my participation in this event. Furthermore, I understand that if my work is accepted and hung in the Show, it may not be removed from the Gallery until after the Show closes. I also agree to permit the WVAG to reproduce my artwork for the purposes of publicity and documentation purposes.
